Purpose of Acceptable Use Agreement for Community Users (AUP)

This Acceptable Use Agreement is intended to ensure:

- that community users of school/academy digital technologies will be responsible users and stay safe while using these systems and devices.
- that school/academy systems, devices and users are protected from accidental or deliberate misuse that could put the security of the systems and users at risk.
- that users are protected from potential risk in their use of these systems and devices.

Acceptable Use Agreement

I understand that I must use school systems and devices in a responsible way, to ensure that there is no risk to my safety or to the safety and security of the systems, devices and other users. This agreement will also apply to any personal devices that I bring into the school/academy.

- I understand that my use of school/academy systems and devices and digital communications will be monitored
- I will not use a personal device that I have brought into school for any activity that would be inappropriate in a school setting
- I will not try to upload, download or access any materials which are illegal (child sexual abuse images, criminally racist material, adult pornography covered by the Obscene Publications Act) or inappropriate or may cause harm or distress to others. I will not try to use any programmes or software that might allow me to bypass the filtering and security systems in place to prevent access to such materials.
- I will immediately report any illegal, inappropriate or harmful material or incident I become aware of, to the appropriate person.
- I will not access, copy, remove or otherwise alter user's files without permission.
- I will not access, use, or take pictures using a mobile or other device unless this has been agreed with the Principal of the school. If permission is given, I will not use my personal equipment to record these images.
- I will not publish or share any information I have obtained whilst in the school on any personal website, social networking site or through any other means, unless I have permission from the school. If permission is given for images to be published, it will not be possible to identify by name, or other personal information, those who are featured.
- I will not install or attempt to install programmes of any type on a school device, nor will I try to alter computer settings, unless I have permission to do so.
- I will not, without permission, make large downloads or uploads that might take up internet capacity and prevent other users from being able to carry out their work.

- I will not disable or cause any damage to school/academy equipment, or the equipment belonging to others.
- I will immediately report any damage or faults involving equipment or software, however this may have happened.
- I will ensure that I have permission to use the original work of others in my own work.
- Where work is protected by copyright, I will not download or distribute copies (including music and videos).
- I understand that if I fail to comply with this Acceptable Use Agreement, the school/academy has the right to remove my access to school systems and devices.

Please read and understand the above agreements and agree to use the school technology systems (both in and out of school) and your own devices (in school and when carrying out communications related to the school) within these guidelines.
